## **Customer Privacy Statement**

Your Personal Data:

#### What we need:

**CAL-COM SYSTEMS LTD** is what is known as the 'Data Controller' of the personal data you provide to us. We only collect basic, personal data about you which does not include any sensitive personal data. This does, however, include:

- name, address and email
- financial information and bank details
- business information such as goods and services
- CCTV images recorded at our premises

### Why we need it:

We may sometimes need to process your data to pursue our legitimate business interests, for example to prevent fraud, for credit decisions, administrative purposes or reporting potential crimes. We also process personal information using a CCTV system at our premises to maintain the security of the premises and for preventing and investigating crime.

Our Data Protection Policy ensures that CAL-COM SYSTEMS LTD:

- complies with data protection law and follows good practice
- protects the rights of customers, staff and partners
- is open about how it stores and processes individuals' data
- protects itself from a risk of possible data breaches

#### What we will do with it:

We will not disclose your information to any company outside of CAL-COM SYSTEMS LTD except to help prevent fraud or if required to do so by law.

Where necessary, we sometimes need to share the personal information with the individual and also with other organizations. We are required to comply with all aspects of the General Data Protection Regulation (GDPR).

We may need to share information with:

- credit reference agencies
- central government
- debt collection and tracing agencies
- police forces
- security organisations
